#### India, US looking at big picture, no FTA: Piyush Goyal



Date: 12 January 2023

India and the US are looking at the "big picture" of trade instead of "one is to one ratio based outcomes", commerce and industry minister Piyush Goyal said while ruling out a free trade pact between the two sides. India and the US had been discussing a mini-trade deal during former US President Donald Trump and restoring Generalized System of Preferences (GSP) for duty-free imports of Indian goods into the US was part of the talks.

### India's imports from China reach record high in 2022

Date: 13 January 2023

India's bilateral trade with China reached a record \$135.98 billion in 2022, Chinese Customs data showed on January 13, 2023, driven by surging Indian imports of Chinese goods that were up by more than 21% last year. India's exports to China, however, fell in 2022, driving an already significant trade deficit beyond the \$100 billion-mark for the first time.

#### Global steel prices set to stabilise in 2023, says CRISIL Ratings



Date: 12 January 2023

Global steel prices (free-on-board, China) are set to stabilise in calendar 2023 on-year, after falling over 40% to \$570-590 per tonne in December 2022 from the early-April peaks of \$1,000 per tonne on tepid steel demand, according to CRISIL Ratings. Following the global trend, domestic steel prices are expected to soften only a minimal 2-4% on-year (for flat steel) in fiscal 2024, after seeing a decline of over 30% last December from the historical highs of April.

#### India's Dec palm oil imports jump 96%; soyoil drops: Trade body

Date: 12 January 2023

India's palm oil imports in December surged 96% from a year earlier to a record high for the month as palm oil's hefty discount to rival edible oils led refiners to raise purchases during the seasonally weak winter period, a trade body said. Soyoil imports in December fell 36% from a year earlier to 252,525 tonnes, while those of sunflower oil dropped 25% to 194,009 tonnes, according to the SEA.

#### UPI, Singapore's PayNow Integration Soon: Official at G20 Meet

The Monetary Authority of Singapore on Monday said integration of India's Unified Payment Interface (UPI) and equivalent network in Singapore, known as PayNow, will begin anytime soon, which in turn will reduce the remittance cost by 10 per cent. There will be interoperability of the two digital payment networks, allowing seamless remittances between the two countries at a highly competitive rate. He said this integration will also help Indian tourists pay in Singapore using UPI.

World Bank predicts India's economic growth to slow to 6.9% in FY23



Date: 11 January 2023

India will be the fastest-growing economy among the seven largest emerging markets and developing economies (EMDEs) in FY23, indicated the World Bank report. India's economy is likely to face multiple growth challenges in the next financial year. Growth in India is projected to slow from 8.7 percent in FY2021/22 to 6.9 percent in FY2022/23, the latter revised 0.6 percentage point lower since June," said the World Bank in its latest Global Economic Prospects Report.



80% shortfall of specialist doctors in CHCs: Health Ministry report

India is reeling under an acute shortage of specialist doctors, with a shortfall of nearly 80% of the required specialists at Community Health Centers (CHCs), reveals the Rural Health Statistics report published by Ministry of Health and Family Welfare on January 12. The Rural Health Statistics report shows that there is a shortfall of more than 80% of the required surgeons and pediatricians in the 6,064 Community Health Centers across the country.

All Omicron variants in air, but no rise in mortality: Govt survey

A community-based surveillance conducted by the government has found that all Omicron variants - from BA.2 and XBB to BQ.1 and their respective sublineages — are circulating in the country.
