

WTO's NTBs Notifications Relating to Iron & Steel Products January 2024

Under the WTO's Agreement on Technical Barriers to Trade, member states, for valid reasons, are allowed to regulate markets, protect their consumers, and preserve their natural resources, using tools such as rules for product weight, size, or packaging; ingredient or identity standards; shelf-life restrictions; and import testing and certification procedures.

However, these measures often result in perceived discrimination against imports to protect domestic industries.

The TBT Agreement seeks to ensure that standards, technical regulations, and conformity assessment procedures are not discriminatory and are applied on a non-discriminatory basis.

This Newsletter captures NTBs notified by WTO members and their relevance to India's Iron & Steel products for the month of January 2024. It also highlights the potential impact of these NTBs on India's exports, if any.

TBT Notifications Issued by WTO Member Countries

A total of 449 TBT notifications were issued by the various WTO member countries during January 2024. Out of these, 6 notifications relate to iron & steel products. These were issued by the 4 WTO Member countries.

Country-wise Break-up of NTBs Notifications




Figure 1. Distribution of Country-wise TBTs Notifications Relating to Iron & Steel Products

A review of TBT Notifications relating to iron & steel products for the month of January 2024 reveals that out of the total 6 notifications, it was followed by Kuwait issuing two notifications, Thailand issuing two notifications, Vietnam issuing one notification, and Israel issuing one notification. See Figure 1 for the distribution of TBT Notifications relating to iron & steel products.

Potential Impact of TBTs Notifications on India's Iron & Steel Products' Export

Analysis of data reveals that notifications issued by the WTO Member countries in January 2024 could potentially affect India's exports worth US\$ 31.68 million if appropriate measures are not taken to resolve these issues in time.

At the country level, a review of data reveals that out of the total potential decline in India's exports, Vietnam alone would account for a decline in India's exports of over US\$ 30.83 million, followed by Thailand at over US\$ 0.61 million, Kuwait at over US\$ 0.24 million and India does not export any of the product to the markets of Israel. A description of Notifications, along with product-wise exports from India to these countries in 2022, is presented in Table 1.
